

Octopus Easy Park Auto-Payment Service Promotion — Terms & Conditions

1. This promotion (this “**Promotion**”) is open to you as a holder of Octopus on iPhone and Apple Watch or Octopus on Android (collectively, categorised as “**Mobile Octopus**” under the Conditions of Issue of Octopus), and is subject to the terms and conditions as stated below (these “**Terms and Conditions**”).
2. This Promotion is organised by Octopus Cards Limited (and its successors and assigns) (“**OCL**”).
3. By participating in this Promotion, you are deemed to have read and accepted, and agree to be bound by these Terms and Conditions.
4. OCL’s Privacy Policy, Conditions of Issue of Octopus, Schedule of Fees and Guidelines relating to the use of Octopus (the “**Schedule of Fees**”), Terms & Conditions for Octopus Online Payment Service, Terms of Use of Octopus App, Terms and Conditions for Octopus Easy Park Auto-Payment Service and other terms and conditions of use, published by OCL at <http://www.octopus.com.hk> and/or the Octopus App, as amended from time to time, shall apply to this Promotion.
5. “**Octopus**”, “**Octopus Wallet**”, “**Mobile Octopus**” and “**Stored Value Limit**” referenced in these Terms and Conditions are defined in the Conditions of Issue of Octopus. “**Octopus App**” referenced in these Terms and Conditions is defined in the Terms of Use of Octopus App. “**Octopus Easy Park Auto-Payment Service**” referenced in these Terms and Conditions is defined in the Terms and Conditions for Octopus Easy Park Auto-Payment Service.

Promotion Details

6. This Promotion will commence at **00:00 on 23 February 2026** (Hong Kong time) and end at **23:59 on 22 April 2026** (Hong Kong time) (both dates inclusive) (the “**Promotion Period**”).
7. This Promotion consists of the Roadshow Offer (as defined in Clause 9) and Promotion Offer (as defined in Clause 13).
8. Subject to these Terms and Conditions, if:
 - 8.1. you are a holder of Mobile Octopus who has not activated the Octopus Easy Park Auto-Payment Service on such Mobile Octopus prior to the commencement of the Promotion Period; and
 - 8.2. you have successfully completed the registration (the “**Easy Park Registration**”) for the Octopus Easy Park Auto-Payment Service within the Promotion Period and have input your vehicle plate number (the “**Eligible Vehicle Plate Number**”) to link it with the Mobile Octopus mentioned in Clause 8.1 above (the “**Eligible Octopus**”); and
 - 8.3. after fulfilling the requirement in Clause 8.2, you have successfully activated the Octopus Easy Park Auto-Payment Service for the first time by tapping the Eligible Octopus at an Octopus reader at the entrance of any participating carpark of the Octopus Easy Park Auto-Payment Service during the Promotion Period (the “**Activation**”),you will be considered a successful participant of this Promotion (an “**Eligible Participant**”, and the “**Eligible Participants**” shall be construed accordingly).

Roadshow Offer – welcome gift of Octopus top-up value of HK\$20

9. If the Easy Park Registration takes place at any dedicated roadshow booth located in one of the designated MTR Malls (as defined in Clause 10) as announced by OCL from time to time, and the Eligible Participant has provided the Eligible Octopus number to a promoter of the roadshow booths for registration of the Roadshow Offer (the “**Roadshow Registration**”), subject to the Roadshow Offer Limit (as defined in Clause 12), such Eligible Participant will be eligible to receive a rebate in the form of

- Octopus top-up value equivalent to HK\$20 (Hong Kong Dollars Twenty Only) as a welcome gift (the "**Roadshow Offer**").
10. For the purpose of these Terms and Conditions, a "**MTR Mall**" means any of the following shopping malls, namely, ELEMENTS, Maritime Square, Maritime Square 2, Paradise Mall, PoPCorn, Telford Plaza, Telford Plaza II, The LOHAS, The SOUTHSIDE, The Wai and Sun Tuen Mun Shopping Center.
 11. For details regarding the date, time and location of the roadshow booths, please refer to www.octopus.com.hk/easypark_2026Q1_offer
 12. The Roadshow Offer is limited and offered on a first-come-first-served basis to the first 2,400 Eligible Participants (the "**Roadshow Offer Limit**") according to the time of the Activation. The time of Activation as recorded by OCL shall be final and conclusive in determining the eligibility of entitlement to the Roadshow Offer. No Roadshow Offer will be offered once the Roadshow Offer Limit is reached.

Promotion Offer – rebate of up to 50% of an Eligible Transaction (as defined in Clause 13.1) and up to HK\$100 in the form of Octopus top-up value

13. Subject to these Terms and Conditions, if an Eligible Participant,
 - 13.1. upon Activation, has completed a payment transaction at any carpark of the MTR Malls (the "**Designated Carpark**", collectively the "**Designated Carparks**") by using the Eligible Octopus during the Promotion Period (the "**Eligible Transaction**"); and
 - 13.2. has successfully registered for this Promotion once during the Promotion Period by providing the Octopus number of the Eligible Octopus on the Promotion website at www.octopus.com.hk/easypark_2026Q1_offer or such other website as announced by OCL from time to time (the "**Registration**").such Eligible Participant will be eligible to receive a rebate in the form of Octopus top-up value equivalent to a maximum of 50% of the total amount of each Eligible Transaction at the relevant Designated Carpark, and up to an aggregate maximum amount of HK\$100 (Hong Kong Dollars One Hundred Only) for each Eligible Participant (collectively, the "**Promotion Offer**"). For the avoidance of doubt, an Eligible Participant needs not complete the Registration before conducting the first Eligible Transaction in order to be eligible to receive the Promotion Offer.
14. The Promotion Offer is limited and offered on a first-come-first-served basis to the first 1,500 Eligible Participants (the "**Promotion Offer Limit**") according to the time of the first Eligible Transaction or the time of Registration as completed by the Eligible Participant, whichever occurs later. The time of an Eligible Transaction will be determined according to the time of exit of the relevant vehicle from the Designated Carpark in relation to such payment transaction as recorded by OCL. The time of the Eligible Transaction or the time of Registration by the Eligible Participant as recorded by OCL in determining the eligibility of entitlement to the Promotion Offer shall be final and conclusive. No Promotion Offer will be offered once the Promotion Offer Limit is reached.
15. Each Eligible Octopus is entitled to enjoy each of the Promotion Offer and/or the Roadshow Offer once only. In case of Octopus on iPhone and Apple Watch user, if more than one Eligible Octopus is added on the same device or added with the same Apple ID during the Promotion Period and is linked with Octopus Easy Park Auto-Payment Service, only the first Eligible Octopus which is being used to conduct the relevant Eligible Transaction and/or complete the Roadshow Registration on the same device or same Apple ID will be entitled to the Promotion Offer and/or the Roadshow Offer. In case of Octopus on Android user, if more than one Eligible Octopus is added on the same device or added with the same Octopus Wallet number during the Promotion Period and is linked with Octopus Easy Park Auto-Payment Service, only

the first Eligible Octopus which is being used to conduct the relevant Eligible Transaction and/or complete the Roadshow Registration on the same device or same Octopus Wallet number will be entitled to the Promotion Offer and/or the Roadshow Offer.

16. Subject to the Promotion Offer Limit and Roadshow Offer Limit, if an Eligible Participant fulfills the eligibility criteria of both the Promotion Offer and Roadshow Offer, both the Promotion Offer and Roadshow Offer will be offered to such Eligible Participant.
17. Under no circumstance can the Promotion Offer and/or the Roadshow Offer be altered, transferred, redeemed or exchanged for cash, other forms of products, services or other electronic value whatsoever.

Eligible Transaction

19. An Eligible Transaction does not include any transaction that is eventually being rejected, reversed or cancelled for whatever reason.
20. Where the Eligible Octopus or Octopus App of the Eligible Participant is suspended, terminated or cancelled, or becomes invalid for whatever reason(s) during the Promotion Period, any and all transactions made through and/or recorded in such suspended, terminated, cancelled or invalid Eligible Octopus during the Promotion Period will not be considered as Eligible Transaction.
21. The time of completing the Eligible Transaction and the transaction value of such Eligible Transaction as recorded by OCL shall be final and conclusive for the purpose of this Promotion.

Collection of Promotion Offer and/or the Roadshow Offer

22. The Promotion Offer in respect of each Eligible Transaction will be made available for collection from the seventh (7th) day onwards after the date of the relevant Eligible Transaction or the Registration (where applicable), whichever occurs later (the "**Promotion Offer Collection Date**"), and must be collected within 30 days from the Promotion Offer Collection Date (the "**Promotion Offer Collection Period**"). The Roadshow Offer will be made available for collection from the seventh (7th) day onwards after the date of Activation (the "**Roadshow Offer Collection Date**"), and must be collected within 30 days from the Roadshow Offer Collection Date (the "**Roadshow Offer Collection Period**").
23. You must follow the steps set out on the official website of OCL at http://www.octopus.com.hk/collection_en to collect the Promotion Offer and/or the Roadshow Offer.
24. Nothing in these Terms and Conditions shall oblige OCL to notify you of the availability of the Promotion Offer and/or the Roadshow Offer or the forfeiture of any Promotion Offer and/or the Roadshow Offer. Nevertheless, OCL will issue push notifications to the Eligible Participant through Octopus App after the Promotion Offer and/or the Roadshow Offer is available for collection if he/she has opted-in to receive push notifications in the Octopus App before commencement of the Promotion Offer Collection Period and/or the Roadshow Offer Collection Period.
25. Each Octopus can only store up to the applicable Stored Value Limit as set out in the Schedule of Fees, currently being HK\$1,000 or HK\$3,000 (as applicable). If the applicable Stored Value Limit has been reached at the time of collecting the Promotion Offer and/or the Roadshow Offer, you must spend such amount of stored value in the relevant Eligible Octopus that is of a value not less than that of the Promotion Offer

and/or the Roadshow Offer before you will be able to collect the Promotion Offer and/or Roadshow Offer again within the Promotion Offer Collection Period and/or the Roadshow Offer Collection Period.

Forfeiture or return of Promotion Offer and/or the Roadshow Offer

26. The Promotion Offer and/or the Roadshow Offer will be forfeited automatically without notice upon occurrence of any of the following events at the time of your collection of the Promotion Offer and/or the Roadshow Offer:
 - 26.1. in the event that the Promotion Offer and/or the Roadshow Offer cannot be credited to the Eligible Octopus in accordance with these Terms and Conditions;
 - 26.2. if the Eligible Octopus and/or Octopus Easy Park Auto-Payment Service has/have been or is/are suspended, terminated, cancelled, or is no longer valid for whatever reason(s);
 - 26.3. in the event that the Eligible Octopus is not connected to any mobile device or the Octopus App has been uninstalled from the relevant mobile device at any time when the Promotion Offer and/or the Roadshow Offer is collected;
 - 26.4. the Eligible Octopus to which the Eligible Vehicle Plate Number is linked is changed during the Promotion Period;
 - 26.5. the Eligible Octopus is no longer linked to the Octopus Easy Park Auto-Payment Service within the Promotion Period; or
 - 26.6. in the event that the Promotion Offer and/or the Roadshow Offer is not collected within the Promotion Offer Collection Period and/or the Roadshow Offer Collection Period with the Eligible Octopus in accordance with these Terms and Conditions.
27. In the case of any fraud or rejection, reversal to the effect that the Eligible Participant should no longer be eligible for the Promotion Offer and/or the Roadshow Offer that has been credited to the Eligible Octopus, OCL shall have the sole and absolute right to debit from the Eligible Octopus an amount that is equivalent to the value of the Promotion Offer and/or the Roadshow Offer without prior notice or to demand the return of the Promotion Offer and/or the Roadshow Offer in such manner as directed by OCL, and under no circumstance shall you have any claim against OCL whatsoever.

General

28. OCL shall not be responsible for any failure in the communication networks, mobile applications, mobile devices or any interruption, interception, suspension, delay, blackout, loss, unavailability, mutilation, incorrect data transmission or other failure in relation to any aspect of this Promotion. Without limiting the generality of the foregoing, OCL makes no guarantee on the availability of the Octopus App and will not be held responsible for interruption of service that may interfere with the ability to participate in this Promotion. Under no circumstance shall any claim be made against OCL whatsoever arising out of or in connection with this Promotion.
29. Any act that is found or suspected to be fraudulent may result in you being disqualified from participating in this Promotion and not being eligible for the Promotion Offer and/or the Roadshow Offer.
30. OCL has the sole and absolute right to modify these Terms and Conditions at any time, which shall be effective immediately upon posting on the website at <http://www.octopus.com.hk>.
31. OCL's decisions in relation to any and all aspects of this Promotion, including, but not limited to, the eligibility of any holder of Mobile Octopus and entitlement of Promotion Offer and/or Roadshow Offer, shall be final and conclusive.
32. Links to third party websites or information in any communication, marketing or promotional materials in relation to this Promotion are provided for your convenience and the convenience of the readers thereof only. If you or any of such readers use(s)

these links, you or such reader will leave the original site and will be subject to the terms contained on any such third party websites. OCL is not responsible for the availability of any such third party websites. OCL has not reviewed, and thus is not responsible for, and accepts no liability in respect of any information or opinion contained on any such third party websites.

33. Any enquiries or issues relating to mobile applications or communication services other than those provided by OCL should be referred to the relevant third party service provider(s).
34. Subject to Clause 33 above, any enquiries or disputes concerning this Promotion must be made to OCL on or before 31 May 2026 by post to Octopus Cards Limited at 46/F, Manhattan Place, 23 Wang Tai Road, Kowloon Bay, Kowloon, Hong Kong or by calling OCL's Customer Service Hotline (no.: 2266 2222).

Without limiting OCL's rights under its Privacy Policy, your personal information (namely, the number of the Eligible Octopus and corresponding information in relation to the Activation, Registration, Roadshow Registration and the relevant Eligible Transaction retrieved by OCL from its system information for the purpose of this Promotion will be used by OCL for (a) identifying and verifying your eligibility to participate in this Promotion and/or to receive the Promotion Offer and/or Roadshow Offer, (b) fulfilling the Promotion Offer and/or Roadshow Offer, (c) sending notification pursuant to Clause 24, and (d) handling any enquiries or resolving any disputes in relation to this Promotion.
36. If you are unable to provide information requested by OCL for handling enquiries or resolving disputes in relation to this Promotion, OCL may not be able to process your enquiry or dispute.
37. Information collected, retrieved or received as aforesaid and which is solely for the purpose of this Promotion will be destroyed by 30 June 2026.
38. These Terms and Conditions shall be governed by, and construed in accordance with, the laws of Hong Kong.
39. No person other than an Eligible Participant and OCL shall have any right under the Contracts (Rights of Third Parties) Ordinance (Chapter 623 of the Laws of Hong Kong) to enforce the provisions of these Terms and Conditions.
